FOREWORD AND DEFINITIONS

By Radu Cotarcea

The biennial *CEE by the Numbers* report – a compilation and presentation of hard data about the lawyers at leading law firms of Central and Eastern Europe – is a source of real pride at CEE Legal Matters. This report is our fourth, following the first in April 2014 (published as part of our special *Glass CEEling* issue), and the second, third, and fourth published as standalone reports in 2017, 2019, and 2021. Like its predecessors, it includes information not only about the size and gender breakdown of the leading law firms in the region but also allows readers to track and measure the growth (or decline) of those numbers over previous years.

We are grateful to those firms that took the time to respond to our inquiries on the matter, and we hope they – and everyone else – will give us their feedback on the issue. We look forward to receiving (and publishing, if possible) that feedback over the months to come.

Methodology

CEE Legal Matters covers the legal markets of Albania, Austria, Bosnia and Herzegovina, Bulgaria, Croatia, the Czech Republic, Estonia, Greece, Hungary, Kosovo, Latvia, Lithuania, Moldova, Montenegro, North Macedonia, Poland, Romania, Serbia, Slovakia, Slovenia, Turkiye, and Ukraine. Due to the ongoing war in Ukraine, we have an embargo on covering the Russian and Belarussian markets, with those two countries being stricken from the data sets used from the past as well. The data in this report was gathered between August 1 and September 31, 2023, from the websites of 733 law firms (with a total of 1,162 offices) ranked by *Chambers & Partners* and *Legal 500* in any one practice area in each of those 22 countries (excepting those law firms which do not distinguish between partners and associates on their websites or which do not list their associates), and from 57 law firms in the region that were not ranked but are part of regional networks that include ranked firms. Each firm for which information was gathered was also contacted and invited to confirm or update the data.

Definitions

For the purpose of the survey, "lawyer"

Re

means all lawyers, at all levels working as full-time fee earners (i.e., junior associate, associate, senior associate, (of) counsel, attorney, partner, etc.). "Associate" means all lawyers who are not partners.

"Regional" law firms are those that are headquartered in CEE or elsewhere in Continental Europe (e.g., Germany) and which have offices in at least three CEE countries. Firms with offices in only two neighboring jurisdictions (such as those with offices only in the Czech Republic and Slovakia, or in Serbia and Montenegro) were categorized as "Domestic."

"International" law firms are those with headquarters outside of Continental Europe but with at least one office in the region.

"Networks" were considered only if they present themselves as an exclusive alliance (e.g., SEE Legal was considered, while Lex Mundi was not).

For the sake of simplicity and consistency, for the purposes of this report, the law firms affiliated with the Big 4 accounting firms (i.e., KPMG, EY, Deloitte, and PwC) or with international firms that are branded differently to satisfy local bar regulations were treated as part of those organizations. For example, Reff & Associates, which is affiliated with Deloitte Legal in Romania, was treated as Deloitte Legal, while Balcioglu Selcuk Ardiyok Keki Attorney Partnership, the Turkish firm associated with Dentons, was treated as Dentons.

LEGAL MARKET SIZE



NUMBER OF LAW FIRMS

Which CEE country has the most law firms ranked by *Chambers & Partners* or *Legal 500* (or both)?

In 2021, Turkiye was at the top of the table with 134 firms ranked, followed by Russia with 117. While the latter was not analyzed in this report, the former saw a sharp decrease in the number of ranked firms – the sharpest, in fact, with 35 fewer ranked firms in the country compared to 2021.

In 2023, Poland took the lead, adding 43 additional ranked offices since 2021.

A total of seven jurisdictions have over 50 ranked firms in 2023, nine in 2021, and 11 in 2019, with Hungary, Bulgaria, and Slovakia (albeit just) dropping below that threshold in the four years analyzed.



The number of firms ranked by *Chambers & Partners* and *Legal 500* has expanded significantly across the entire region over the past couple of years, in contrast with the findings of the 2021 CEE by the Numbers report, according to which the number of ranked firms had decreased in almost every country between 2019 and 2021.

17 of the 22 analyzed markets have more ranked firms in 2023 than they did in 2021. 14 of them have compensated for the decrease in numbers between 2019 and 2021 and now have more ranked firms than they did in 2019.

Of the four countries nearing or past 100 ranked firms, Turkiye deviates from the trends across the past four years. In the 2021 CEE by the Numbers report, Turkiye had the highest growth in terms of the number of ranked firms. In 2023, it is the country with the highest decrease in that number. Poland, Austria, and Ukraine registered a drop between 2021 and bounced back. Greece, which completed the Top 5 countries with most law firms had a steady small decrease over both data points.



NUMBER OF LAWYERS

Same as in the 2019 and 2021 *CEE by the Numbers* reports, Poland leads the way in terms of the number of lawyers working at ranked firms, with a total headcount of 5,291. Austria jumped into the second spot with a total of 2,538 lawyers. Turkiye follows in third with 2,071.


Four jurisdictions – Turkiye, Montenegro, Albania, and Moldova – have fewer lawyers working in total at ranked firms in 2023 compared to 2021. Comparing 2023 to 2019, five markets have a smaller total headcount (in order of decrease): Ukraine, Bulgaria, Slovenia, Bosnia and Herzegovina, and Montenegro.

Poland, Austria, Greece, Lithuania, and the Czech Republic, in that order, registered the highest increases in the total number of lawyers at ranked firms.



While Turkiye saw the highest decrease in the last couple of years (584 lawyers fewer at ranked firms in the country), it still has 529 more lawyers working at ranked firms in total compared to 2019.

Poland, which led the table in both 2019 and 2021 saw the highest increase with 1,651 more lawyers working at ranked firms in 2023 compared to 2021 – 1,857 more when compared to 2019.

AVERAGE SIZE OF LAW FIRMS

The top three markets in 2023 remain Poland, Lithuania, and the Czech Republic when it comes to the average size of ranked law firms. However, Lithuania moved up to take the second spot, previously held by the Czech Republic. Poland keeps its top spot but its average headcount of 40.39 is slightly lower than in 2021 (41.36).

Romania (now with 28.23) moved up to the fourth spot taking Austria's place despite the latter also increasing from 24.04 to 25.13.

Of the surveyed 22 markets, seven have an average lower than 10, six have an average between 10 and 20, and nine have an average of over 20 lawyers working at ranked firms.

CHANGING TEAM SIZES

The 2021 *CEE by the Numbers* report found that all but two jurisdictions (Serbia and Slovenia) increased the average number of lawyers at ranked firms over the previous two years, a reversal from the 2019 results where the average size of ranked law firms had decreased across most of CEE, with only two jurisdictions (Turkiye and Serbia) showing an uptick between 2017 and 2019.

In 2023, the trend seems to have circled back to a decrease in average headcounts, albeit more moderate than in the 2019 results. 12 of the 22 analyzed jurisdictions saw a decrease in the average number of lawyers at ranked firms in 2023 compared to 2021. Of the remaining 10 that did see an increase, Greece and Romania saw the highest jump, with 5.6 additional lawyers on average per ranked firm and 5.41, respectively. On the opposite side of the spectrum, Ukraine's average number decreased by 5.43.

While more jurisdictions registered a decrease in their averages than an increase in 2023 compared to 2021, the averages still are higher in most countries compared to 2019. Only Bosnia and Herzegovina, Montenegro, Serbia, and Ukraine have fewer lawyers, on average, working at a ranked firm.

SIZE VS NUMBER OF FIRMS

In the 2019 CEE by the Numbers report, looking in parallel at the change in the number of ranked firms and their average headcount, it would have either appeared that firms across CEE were streamlining or, as indicated to be more likely, it reflected, "at least in part, a splintering of the markets, with spin-offs and new challengers able to challenge more established firms for dominance." Looking at the same two data sets in 2021, a story of market consolidation could be read with most jurisdictions having fewer small firms ranked, thus explaining the trends of fewer ranked firms while the average number of lawyers increases.

The 2023 numbers highlight Greece, Romania, Slovakia, Slo-

venia, and Turkiye as the countries that show signs of market consolidation, with six fewer ranked firms in both Greece and Romania but an average number of lawyers increasing by 5.6 and 5.41 in Greece and Romania, respectively.

12 markets registered an increase in the number of ranked law firms and a decrease in the average number of lawyers working at them, which would seem to indicate a splintering of those markets.

Austria is a notable outlier here since it saw the addition of 25 ranked firms while also registering an increase in the average number of lawyers working at ranked firms by 1.09.

Of course, false dichotomies should be avoided and the numbers for Austria for 2023 compared to 2021 highlight that it is not just a matter of either market consolidation or splintering.

For example, an increase in both the total number of ranked firms in a country and an increase in the average number of lawyers working at them might reflect pure market growth. Alternatively, it might simply be that the market has stayed the same but the ranking directories used grew more generous in their inclusiveness.

In fact, of the 22 analyzed jurisdictions, five increased both in terms of the number of ranked firms and average size between 2021 and 2023, and 11 did so between 2019 and 2023.

LEGAL MARKET SATURATION



NUMBER OF FIRMS / GDP

One method of assessing the level of saturation in each market is to compare each country's gross domestic product (as reported by the World Bank for 2022) to the number of ranked firms in that specific market. When seen through this lens, same as in the 2021 and 2019 *CEE by the Numbers* report, Montenegro appears to be the most crowded market, with Turkiye being the least crowded.

Compared to the 2021 report, Turkiye jumped from third place back to the top spot it held in 2019 – "powered" by it registering 35 fewer ranked firms in 2023 than in 2021 while also showing a considerable increase in its GDP. The Czech Republic overtook Austria for the first time, primarily as a result of the latter's addition of 25 firms.

In the 2021 report, CEE markets seemed to be less crowded overall compared to 2019, with 16 of the 22 jurisdictions increasing their ratio between 2019 and 2021, while Turkiye, Kosovo, Greece, Slovenia, Serbia, and Slovakia had a lower ratio than in 2019. In contrast, markets seem more saturated in 2023 with 13 jurisdictions of the 22 jurisdictions decreasing the GDP to ranked firm ratio.

Since 2021, Turkiye had the highest ratio increase, while Poland saw the highest decrease. When compared to the 2019 ratios, the Czech Republic increased its ratio the most, while Kosovo recorded the highest decrease.

GDP / NUMBER OF LAWYERS

Turkiye is also the least crowded when comparing the number of lawyers at ranked firms against its GDP, with a GDP-toranked-firm-lawyers ratio of 437.46. Estonia reclaimed its place at the top in terms of most saturated markets considering the total number of lawyers, with the Baltic countries of Lithuania and Latvia taking the second and fourth spots, respectively while Serbia kept steady as the second most saturated marked based on this metric.

In contrast, Poland, with its highest increase in the total number of lawyers working at ranked firms, drops from the seventh spot to the 15th, while Austria slipped from third to seventh.

Following Turkiye, which had the highest increase in the ratio since 2021, Montenegro, which took Estonia's first place in

2021, dropped to the fifth spot in terms of most saturated markets by having the second highest ratio increase.

Compared to the 2019 data, Kosovo had the highest decrease in the ratio, followed by Turkiye. In terms of ratio increases, Bosnia and Herzegovina and Bulgaria lead the way with increases of 73.74 and 45.61, respectively.

SATURATION VS GROWTH

In the 2021 CEE by the Numbers report, it was shown that Poland, Austria, and Turkiye were the countries with the lowest saturation in terms of their ratios of GDP to the number of ranked law firms. Since then, Poland registered the highest increase in the number of ranked firms. Austria, which ranked second in terms of lowest saturation, followed closely with an increase of 25 but it was overtaken by Ukraine, which, despite being in the middle of the table in terms of saturation, saw the second-highest increase in the number of ranked firms since 2021.

Turkiye stands out for losing 35 ranked firms in the last couple of years but it still has 20 more than it did in 2019 – an overall increase only exceeded by Poland.

When comparing the GDP-to-ranked-firm-lawyer metric to the evolution of the number of lawyers at ranked firms over the years, Turkiye, which had the highest ratio in 2021, stands out as, perhaps surprisingly (and if we do not consider the market's recent economic woes), decreasing the number of lawyers working at ranked firms by 22% compared to 2021. The current total headcount, however, still represents a 34.31% increase from 2019.

Bosnia and Herzegovina and Slovenia have grown compared to 2021, as their low saturation would predict, but they are still registering a decrease when compared to the numbers in 2019.

Austria's increase in the number of ranked lawyers by 38.92% from 2021 is to be expected given the high ratio in 2021, while Poland's increase of 45.46% (the highest in the region) seems high relative to its ratio being in the second third of the table.

On the flip side, while relatively modest growth in Serbia would be in line with its rather high saturation rates, the increase in the total number of lawyers at ranked firms in the Baltics (around 37-38%) is counterintuitive given those jurisdictions' relatively high saturation levels.

Of the 733 law firms ranked across the surveyed 22 countries, 665 were Domestic, 40 were Regional, and 28 were International.

57 additional unranked Domestic firms were looked at, as they were part of a Network that included ranked Domestic firms (see definitions on page 3).

Domestic firms have a total of 776 ranked offices across the region (832 if Network firms are added).


Regional firms have a total of 181 offices across CEE, while International ones have 149. Of those, 123 Regional firm offices are ranked, while 126 of the International offices show up in the rankings.


Looking at the evolution of the number of offices – both in the case of ranked or unranked affiliated ones – while the overall numbers decreased slightly between 2019 and 2021, they jumped back up between 2021 and 2023. Over the last four years, the number of Domestic ranked offices increased from 722 to 776, the number of ranked offices of regional firms increased from 114 to 123, and that of international firms from 120 and 126.

While the number of Regional offices – either ranked or unranked – was fuelled by several formerly Domestic firms opening up a third office, the number of International firms increasing is influenced to a great extent by the increased number of reported offices affiliated with the Big 4.

REGIONAL FIRMS IN CEE

Similarly to the 2019 and 2021 *CEE by the Numbers* reports' findings, the Baltic states have the most Regional firms, with a large number of pan-Baltic firms. In terms of ranked offices, Lithuania edged into the lead in terms of ranked regional offices compared to 2021 when it shared the spot with Estonia. However, the number of actual offices of regional firms has remained the same – 15.

Greece, Moldova, and Kosovo continue to attract little attention from regional firms with Greece having two, Moldova having one, while Kosovo has zero ranked offices but two unranked offices of regional firms.

When looking at the percentage of ranked offices, Latvia shared the top spot with Estonia in 2021. In 2023, it took the lead with 45.45% of the ranked offices in the country being a part of a regional firm. After the Baltics, the Western Balkans have the highest percentage of ranked firms that are a part of a regional firm.

INTERNATIONAL FIRMS IN CEE

While Poland ranked sixth in terms of the number of Regional firms doing business in the country, it leads the way in the number of International firms on the ground, as 21 have offices in the country, 20 of which are ranked.

The Czech Republic is in the second spot, with 15 ranked offices (out of 15 in total), followed by Hungary with 13 International firms (all ranked).

Similar to the findings of the 2021 report, the Baltic states

dropped in this ranking, with only Eversheds Sutherland and some or all of the Big 4's legal teams operating in the three countries. Similarly, the Western Balkans only have Big 4-affiliated firms in terms of International firms' presence.

In terms of the percentage, Hungary continues to lead the pack with 30.23% of the ranked firms in the country being offices of International firms, followed by the Czech Republic with 24.59%.

MARKET BREAKDOWN BY TYPE

Primarily as the result of pan-Baltic alliances, the Baltics continue to be at the top of the table when comparing the number of ranked Regional and International firms to that of Domestic firms.

Compared to 2021, North Macedonia saw the highest increase in the percentage of ranked firms that offices of Regional or International firms – an increase by 21.15 percentage points. Kosovo and Bosnia and Herzegovina also saw Domestic firms losing ground by over 10 percentage points. Baltic markets saw the biggest gains from Domestics with Latvia, Estonia, and Lithuania, decreasing the percentage of non-Domestics by 9.7, 9, and 7.37 percentage points, respectively. Poland, the market with the highest increase in the total number of ranked firms, saw Domestic firms' percentage increase by 5.53 percentage points over the last two years (4.88 percentage points over the last four years).

ASSOCIATES-PER-PARTNER RATIO

In order to better understand the seniority structures of law firms across CEE, we calculated the average associates-per-partner ratio in each country.

Given the relatively small size of the markets and the law firms working within them, it is perhaps not a big surprise that that ratio is lowest in Albania and Bosnia and Herzegovina. Bulgaria, with a ratio of 1.94, is in third place, while Kosovo, which ranked first in 2021, is now in fourth place in 2023.

Comparing the current numbers to past reports, Ukraine decreased its associates-per-partner ratio the most in the last two years, followed by Turkiye and Bulgaria. Over a four-year period, Ukraine still has the highest decrease but it is followed by North Macedonia and Bosnia and Herzegovina.


Kosovo is the only country where the average number of associates per partner increased by more than one between 2023 and 2021. Comparing 2023 to 2019, Poland had the highest increase (0.71), followed by Latvia (0.63) and Slovakia (0.61).

RATIO BY TYPE OF FIRM

Similarly to the 2019 and 2021 *CEE by the Numbers* reports, on average in CEE, the associates-per-partner ratio tends to be lower in Domestic firms (an average of 2.65) than in Regional (3.12) and International (4.37) firms. Domestic firms that are a part of a regional exclusive network seem to be the most top-heavy, with an associates per partner ratio of 2.33.

Looking at the same data from the previous reports, these ratios have increased for all types of firms over the past four years except for Network members, who decreased their ratio by 0.18 since 2019. International firms have added most associates relative to partners over the last four years, with an increase of the ratio by 0.76.

As a subcategory of International firms, Big 4-affiliated law firms in CEE continue to have the highest associates-per-partner ratio -6.3 in 2023. This marks a decrease compared to 2021 when the ratio was 7.2.

WOMEN IN LAW



FEMALE LAWYERS

In 2023, women accounted for 50.05% of all lawyers at ranked firms in the region, including 62.35% of all lawyers at ranked firms in Greece. Women account for over 60% of all lawyers at ranked firms in Montenegro, Bosnia and Herzegovina, Croatia, and Turkiye, and accounted for more than 55% in nine countries in total. Of the 22 jurisdictions analyzed, only nine have fewer than 50% of all lawyer positions held by women. Kosovo and Austria have the lowest percentages with 30.77% and 38.61%, respectively.

The percentage across the region (50.05%) has increased over the last four years from 2019, when 47.46% of all lawyers were women, despite a slight decrease between 2019 and 2021, when the percentage fell to 46.70%.

Compared to 2021, the highest increase was in Albania, Montenegro, Croatia, and Turkiye, each increasing the percentage of female lawyers by over 10 percentage points. The highest increase since 2019 was in Bosnia and Herzegovina and Albania, each increasing the percentage of female lawyers by over 10 percentage points.

FEMALE ASSOCIATES

When looking at associates only, 18 jurisdictions out of 22 have more female associates than male associates.

Greece and Montenegro keep their first and second spots in terms of the percentage, with Greece having over 70% of all associates being women. Croatia jumps into third with 66.41%. In fact, 12 countries have over 60% of their associate ranks filled up by women.

Compared to the overall percentage of female lawyers of 50.05%, the percentage of female associates across CEE is 55.87%. At the lower end of the table, Kosovo has only 42.31% of all associate positions held by women, followed by the Czech Republic and Austria with 45.40% and 45.61%, respectively.

FEMALE PARTNERS

56.25% of the partners at ranked firms in Bosnia and Herzegovina are women. Followed by Romania with 51.29%, these are the only two markets in CEE that have a female partner percentage of 50% or above.

Of the 22 jurisdictions surveyed, 12 markets have an average percentage of female partners over the regional average of 32.67%. Estonia just missed the line with its 32.48%.

Kosovo, the Czech Republic, and Austria retain their last three spots on the table.

Compared to 2021, the highest percentage increases were in Montenegro, Albania, and Estonia, with 23.75, 8.34, and 6.08 percentage points more, respectively. The highest decreases were in Bosnia and Herzegovina, Kosovo, and Bulgaria, with 8.04, 7.31, and 6.54 fewer percentage points, respectively.

WOMEN IN LAW GAP

Arguably more relevant since it would indicate a more equitable career progression path, putting those numbers together allows us to see the revealing gap between the percentage of female lawyers and the percentage of female partners at ranked law firms across CEE.

Kosovo, which has a percentage of female lawyers of 42.31%, only has a percentage of female partners of 7.69%, thus leading the way in the gap between the two metrics.

In contrast, in large part because Bosnia and Herzegovina and Romania had the highest percentages of female partners at ranked law firms in CEE, those countries have the smallest gap – Bosnia and Herzegovina registering 8.66 percentage points difference and Romania just over 10.

Also telling are the associates-per-partner ratios within firms. In Kosovo, for example, firms have, on average, 2 associates per partner. In contrast, there are 11 female associates per female partner, resulting in a gap of ratios of 9. The Czech Republic, which was 10th in terms of the percentages gap, jumps to second place in the ratios gap with a ratio of 3.71 associates per partner contrasted to a ratio of 8.23 female associates per female partner.

Bosnia and Herzegovina, Romania, and North Macedonia are the only jurisdictions with a ratio gap smaller than 1, registering 0.27, 0.66, and 0.78, respectively.
